Paying for your Funeral Plan

Paying for your funeral plan shouldn't be daunting. You can plan ahead with Coles with various, flexible payment options available.

You can choose from the following options:

01

Single Payment Option

With a one-off lump sum payment you can rest assured that everything is settled in advance.

02

12 Monthly Payments Option

If you would prefer to spread the cost, you can pay over 12 monthly payments by Direct Debit at no extra charge. You will be covered once all payments are made.

The plan options listed on the next page provide an illustration of the funeral plans available. The retail price of your funeral plan is representative of the equivalent cost of a funeral today plus an arrangement fee of £325 which is retained by Golden Charter to help cover the costs of setting up your plan. Also included in the plan price is an allowance towards third party costs. Prices are applicable from 22nd October 2024 and subject to change without prior notice. Plans and prices are examples only. Instalment Payment Option

For a lower monthly payment, you can also choose to spread the cost of your plan between two and 15 years. This option includes the added benefit of the **Golden Charter Pledge**, which ensures that if you die at any time after you have made 12 payments, and your payments are up to date, the benefit of your plan will be provided, with no further sums to be paid. An instalment charge is included based on the term you select and is included in the overall cost of your funeral plan.

Frequently Asked Questions

What is a Funeral Plan?

A funeral plan is an easy way to pre-arrange the funeral you want and pay for our funeral director services.

With a Golden Charter funeral plan, you can pay for your plan in several ways. Spread the cost or make a one-off payment – simply choose the one that's right for you. We will provide you with the information you need to make an informed decision.

The retail price of your funeral plan is representative of the equivalent cost of a funeral today plus an arrangement fee of £325 which is retained by Golden Charter to help cover the costs of setting up your plan.

Your payments are held within the Golden Charter Trust. With almost £1.2 billion under management¹, the Trust is operated by a Board of Trustees, completely independent of Golden Charter. Their role is to hold your payments and ensure that the funeral director services in your plan can be paid for at the time they are required – however far into the future that may be. My funeral wishes are included in my Will. Do I still need a Funeral Plan?

Wills are often left unread until after the funeral, so your wishes may not be passed on until after the service. Plus, planning ahead in this way does not offer a chance to fix the costs of our funeral director services at today's prices.

What are the costs?

You can contact your nearest funeral home for the most up-to-date pricing to suit your wishes and budget.

What will my loved ones need to do when the time comes?

As your funeral director, we will hold full details of your funeral plan. When the time comes, one phone call is all it takes to activate your plan and get the arrangements underway.

Are there any additional costs I need to be aware of?

As well as covering the delivery of your funeral as per the terms and conditions of your plan, your plan price includes a £325 arrangement fee, which Golden Charter retains as a contribution towards setting up your funeral plan and a £49 administration fee. A plan from Golden Charter also includes an allowance towards third-party costs. These are essential, non-funeral director services such as the cremation or burial fees, plus the minister or officiant's fee to perform the service. There will only be more to pay at the time of the funeral if the third-party costs exceed the allowance when you buy your plan, or if the costs increase by more than the growth of your plan. Even if prices rise in the future, once your plan is paid for, you'll have the reassurance of knowing there'll be nothing more to pay for our services included in the plan – guaranteed.
